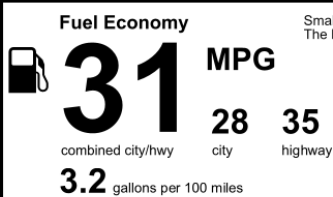

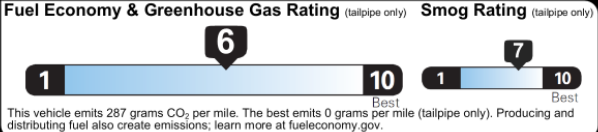
Gasoline Vehicle
