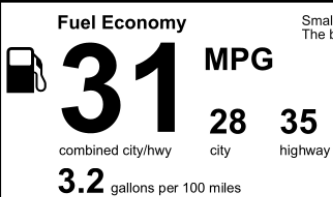

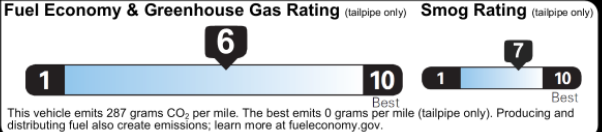
Gasoline Vehicle
